January 5, 2010

The First Meeting of the Chester County Board of Commissioners was held on Tuesday, January 5, 2010, in the Commissioners' Board Room. The Meeting was convened at 11:00 a.m. by Chairman Terence Farrell. Commissioners Carol Aichele and Kathi Cozzone were also present.

III. CONFIRMATION OF ADMINISTRATION AND FILING OF OATHS

The nomination failed for lack of a second. Commissioner Farrell called the vote. Commissioners Farrell and Aichele voted in favor of Carol Aichele. Commissioner Cozzone voted against. Commissioner Aichele was named Chair.

ELECTION OF CHAIRMAN

Commissioner Farrell then congratulated Commissioner Aichele and resigned as Chairman, turning the meeting over to newly elected Chairperson of the Commissioners, Carol Aichele.

VI. NOMINATION AND ELECTION OF VICE CHAIRMAN

Commissioner Aichele called for nominations for Vice Chairman and placed the name of Commissioner Terence Farrell in nomination. Commissioner Farrell seconded the Motion. Commissioner Cozzone nominated herself for Vice Chairman, but the nomination failed for lack of a second.

ELECTION OF VICE CHAIRMAN

Commissioner Aichele closed the nominations and called for a vote on the nomination of Commissioner Farrell for Vice Chairman. Commissioners Aichele and Farrell voted in favor of Commissioner Farrell as Vice Chairman; Commissioner Cozzone voted against. Commissioner Farrell was named Vice Chairman of the Board of Commissioners.
