To vote for an individual candidate of another party after darkening the oval of your party choice, darken the oval to the left of his/her name.</p> <p>3. To cast a write-in vote for a person whose name is not on the ballot, you must blacken the oval to the left of the line provided, and write or print the name in the blank space provided for that purpose.</p> <p>4. To vote in FAVOR of a question, fill in the oval to the left of the word YES. To vote AGAINST a question, fill in the oval to the left of the word NO.</p> <p>5. Use only a black pen or marker.</p> <p>6. If you make a mistake DO NOT ERASE.
